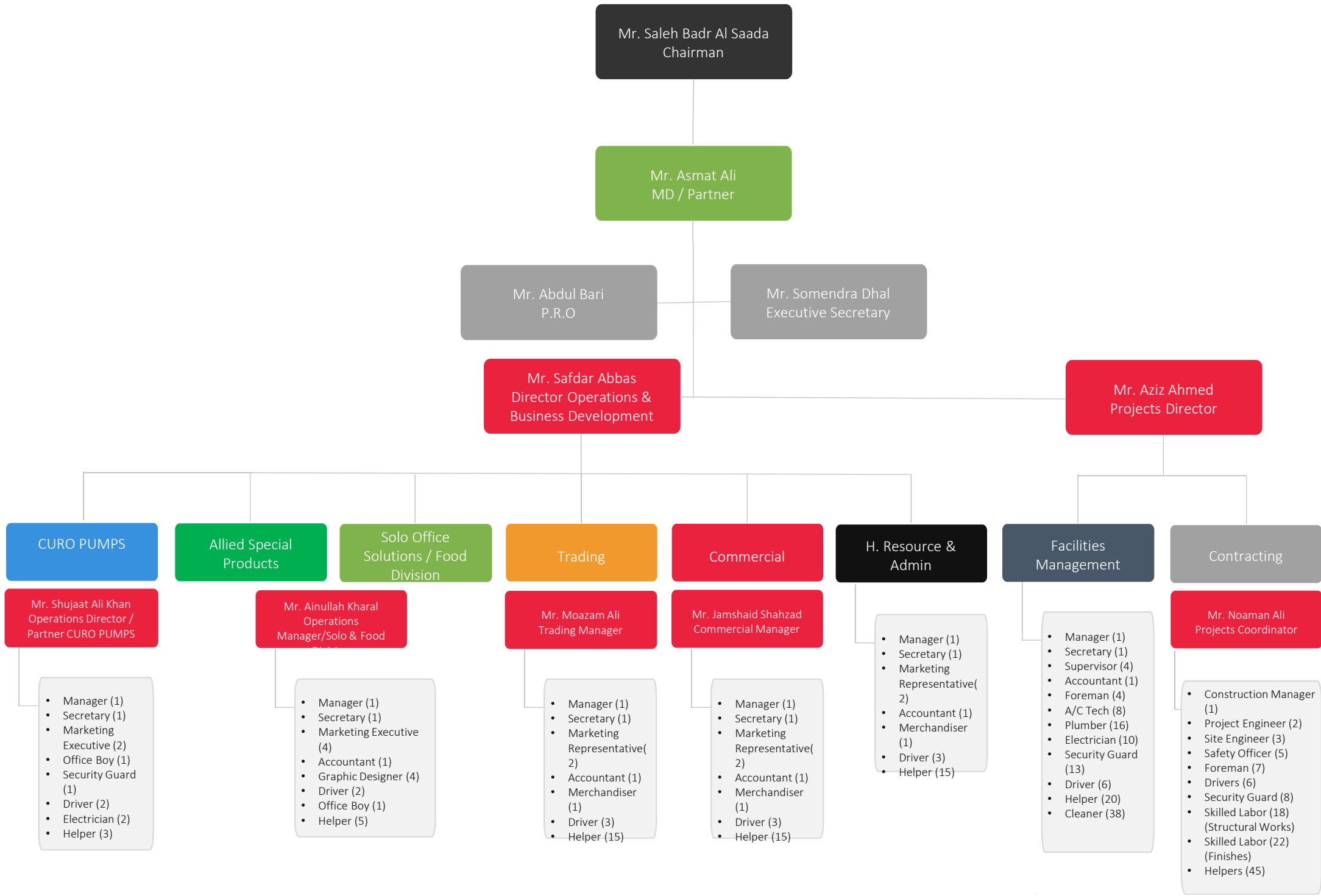

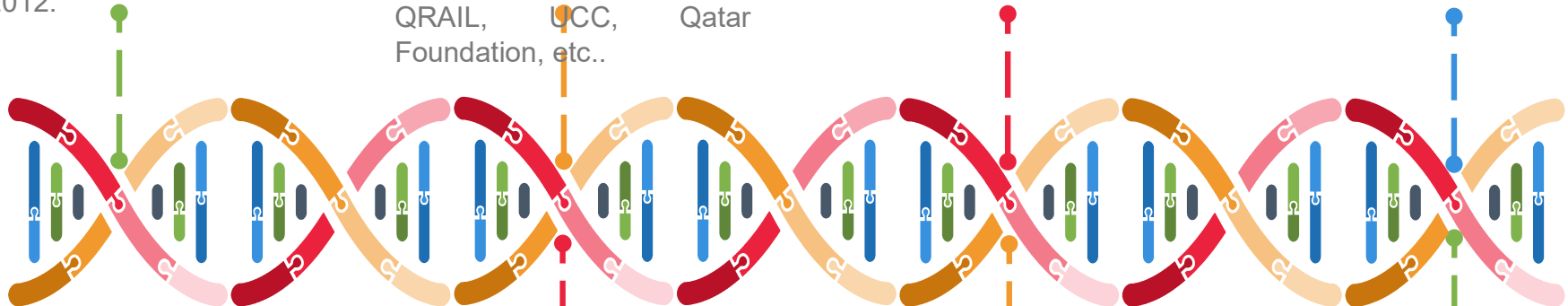

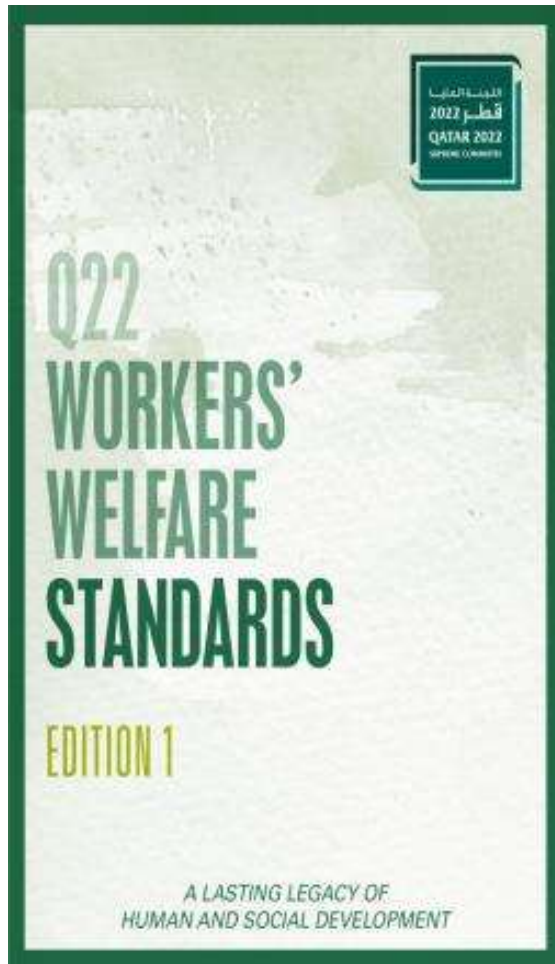

Fourth Precinct Stadium (Ras Abu Aboud)

Qatar has earned the right to act as the host nation for the 2022 FIFA World Cup, and the entity responsible for execution of the development plan in accordance with its bid to FIFA is the Supreme Committee for Delivery & Legacy (SC).

Given the uniqueness and attractiveness of the Site, the SC has decided to engage in a public-private partnership arrangement for the Doha Port Stadium Project and issued a RFP to potential developers on 5th May 2016 to submit their Proposals for investment and development of the Project on BOT basis.

We, Allied Group were one of the developers invited by the SC to submit our proposal and on the basis of our impressive concept plans; we were short listed as one of the 3 selected bidders by SC.

Fourth Precinct Stadium (Ras Abu Aboud)

SC has allocated a plot measuring 809,000 SQM in Ras Abu Aboud Area for the development. The development is comprised of two (2) main aspects.

Stadium: A plot measuring 156,000 SQM from development has been allocated for construction of a stadium to accommodate at least 40,000 spectators. The stadium will have a field developed as per FIFA regulations for a world cup football pitch. The stadium can be converted in to any commercial or entertainment facility post FIFA 2022 world cup.

Collateral Developments: 653,000 SQM from the overall development is allocated for Collateral developments, where the developer is free to construct commercial, residential units, etc. to generate maximum revenues without altering overall intention of the project.

In consideration of the above, we (Allied Group) have developed an impressive concept plan titled “**Al Manara City**”, which is comprised of Residential Apartments, 5 and 4 Star hotels and restaurants, Floating chalets, Souq, School, Hospital, Free holding residential and commercial units, Stadium to be converted in to a shopping mall after successful completion of FIFA 2022 world cup including required amenities for the development.

The overall cost for the development is estimated to be USD. 2.5 Billion (US Dollars Two Billion Five Hundred Million only)

Note:

SC has decided to construct the stadium using shipping containers, removable seats and other modular ‘building blocks’ and in process of awarding stadium project to potential contractors. However we are in liaison with SC to award us collateral developments surrounding stadium



The main factors that support our bid are as follows:

- Local establishment
- Strong technical viability of concept design
- Impressive concept plan, practical for the State of Qatar and viable for 50 Years
- Strong financial support
- No Guarantee required from Government, required only lease agreement as per the terms and conditions set-out in RFP and subsequent communication.

As evident from our concept design, its viability and revenues, our bid was utmost competitive.

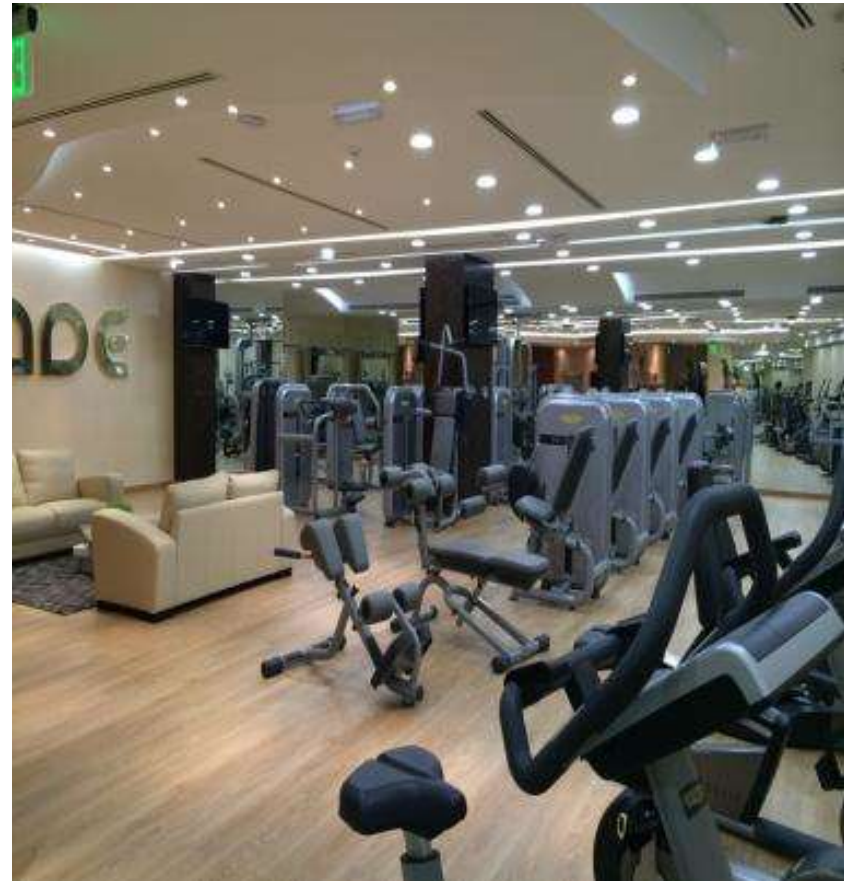

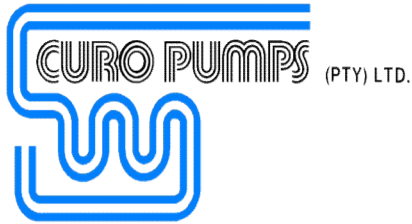

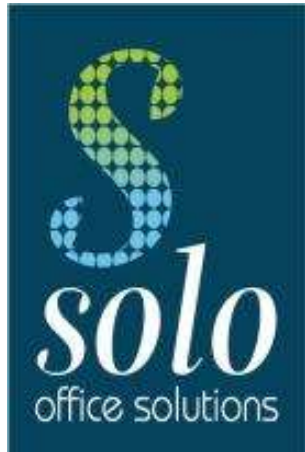
